

ESC Corporate Services Ltd. Terms & Conditions of Use

- 1. **Grant of Licence:** ESC Corporate Services Ltd. ("ESC") grants to the subscriber through its employees ("you", "your") a non-exclusive non-transferable licence to use this Web Site to request products and services, solely for your business purposes, including: searches and copies of search results, electronic filings, registrations, and provision of supplies ("Services"), only in accordance with and subject to the terms and conditions of this Agreement.
